Our Terms and Conditions

Star Limo LLC will maintain the passenger manifest to schedule shuttles on an as needed basis for reservations and manifests submitted prior. By event company, event planner and or their representatives and individual passengers. Star Limo LLC will accommodate passengers whose flights are delayed. Star Limo LLC and its affiliates agree to provide ground transportation services to INDIVIDUAL passengers who make reservations in advance. Reservations and adjustments will be accepted up to 72 hours prior to event date. Visiting GROUP or individuals agree to provide final and completed arrival and departure manifests no later than 7 DAYS before beginning of event arrivals. Star Limo LLC and its affiliates agree to provide ground transportation services to INDIVIDUAL passengers who make reservations in advance. Reservations and adjustments will be accepted up to 72 hours prior to event date. Visiting GROUP or individuals agree to provide final and completed arrival and departure manifests no later than 7 DAYS before beginning of event arrivals. Transportation company will allocate the proper vehicles based on manifest and schedule submitted prior based on grouping of travelers and joining of multiple arrivals of shared ride participants.

Star Limo shuttle service will be available for all pre-scheduled reservations. All on-the-spot reservations will incur a Full rate service. "On the Spot Service" occurs when someone has not booked a reservation and comes off the plane or from hotel and asks for service "on the spot", or a passenger that arrived later than anticipated and does not want to wait for the next available shuttle. If an individual has made a reservation in advance and their flight is delayed, Star Limo LLC will service the passenger arriving late on a first come first served and available basis, meaning they will be taken on the next available shared ride shuttle. An example of "first come first served" services is when an individual has booked a service to the hotel through the website or by phone and the plane arrives late or is cancelled and they arrive on a later flight. Travelers bear burden to inform company of their updated travel information. Travelers with excessive luggage and or golf bags may have to wait to be accommodated with proper vehicles

All changes to pre-existing reservations will require a \$25 change fee per passenger ; delayed flight changes and cancelled flights are excluded from the change fee . Registration will stop 7 days before conference. Any reservation that needs to be made due to urgent nature will incur an additional flat \$ 25 surcharge ,per reservation ,per individual ,per transfer, per adjustment.

Visiting EVENT company will promote Star Limo LLC its affiliates as their exclusive ground transportation agent by listing them in print and web information for conference attendees to provide shared ride shuttle & private car service in New Mexico. Visiting Event company will link and relay Contact information and website links to event attendees for reservations .

Cancellation

All reservations are 100% non-refundable. Refunds are not refunded to "no shows" even if due to flight cancellations and any circumstance beyond the control of either party - such as acts of God, war, acts of terrorism, government regulations, disaster, strikes , civil disorder, or curtailment of transportation facilities - in the event that such circumstances makes it illegal or impossible to provide or use transportation.

I authorize STAR Limousine L.L.C. and or its affiliates to charge all expenses related to all reservation made by me or by someone else on my behalf.

I understand these charges may or may not include and are not limited to tolls, Airport parking, waiting time, stops, 20% driver gratuities Payment for reservation for tour guide/ airport concierge is non-refundable!
